#### **Course Description:**

This course will explain China's government budget system and fiscal policy and help students to understand the history, the present and the future of China's public finance. The course will make an in-depth analysis on China's current public revenue and public spending system. We will present some facts about China's government budget, structure of taxation and fiscal policies as well as the implications of these policies for the economy of China and the world. The course will also involve a comparative study between China and other countries on public finance system.

- a) The socialist planned economy from 1949 to 1978. The theoretical and historic background of the planned economy in China.
- b) The process and strategy of reform from planned economy to market economy.
- c) The reform in rural areas. From the collective agricultural system to the “household responsibility system”.
- d) The reform in urban areas. The reform of SOEs and their’s roles to reform.

### **2. The government system of China and the roles of government in economic and social development.**

We will present some facts about China’s government system.

- a) The government system of China; The structure of government and function of different part of government.
- b) The roles of government in economic and social development.
- c) The roles of SOEs.
- d) The mechanism of formation and making of economic policies in central level.

### **3. The analysis on structure of revenue and spending of government.**

We will present some facts about China’s structure of government.

- a) The government revenue system.
- b) The taxation system.
- c) The structure of spending and the changes in recent years

### **4. Reform of inter-government fiscal relationship.**

We will present some facts about the fiscal relations between central and local governments.

- a) The basic fact about the difference among regions (Eastern, Western and Central regions) in economic and social development
- b) The inter-government transfer system.
- c) The issues of debts of local government in recent years.

### **5. Analysis on fiscal policy since 2008.**

In recent years, China has experienced severe impacts from the global financial crisis. In response to the crisis, China government has taken positive and effective macroeconomic policies to promote economic growth and these policies have made remarkable achievements so far. In this part, we will present basic facts and figures about economic growth, inflation and unemployment, international balance of China between 2008 and 2012, and we will make analysis on the targets, tools and priorities of fiscal policy in this period.

- b) The change of macro-economic policies since 2008.

- c) The targets, tools of fiscal policies.
- d) The new issues of fiscal policies in current.
