
OUR PROGRAM

The IPP has four programs according to the main academic field. Among them, the Asian Public Policy Program (APPP) and the Foreign Service Sub-program (FSS)* are designed for international students and offer all courses in English.

*The FSS is a sub-program within the Global Governance Program.

Although each program has a distinct area of specialization, students can take courses across different IPP programs to enhance their knowledge and skills.

Students from across Asia come together to learn, collaborate, and grow, building bridges across cultures and creating lasting impacts across borders.


Whether you are from Asia or beyond, here you will gain a deeper understanding and diverse perspectives on international relations and public policy within our learning community.

The APPP places a strong emphasis on economic policy, with almost all the required and elective courses structured around economics and its applications to policy. You will gain the essential skills to formulate and analyze policies grounded in solid economic theory, preparing you thoroughly for leadership roles in the field.

Strong networks across Asia

Many APPP students have backgrounds in the ministries of finance, national tax agencies, central banks, and other public sectors in Asian countries. You will learn while being inspired by your fellow students and build strong relationships with them, which will be valuable assets for your career.



Exchange Program

Double Degree Program

For students who want to spend one or two semesters at IPP, IPP welcomes students from partner universities with our exchange program and double degree program.

Exchange students at IPP can fully pursue their academic interests, as they can take any courses* related to their academic interests at IPP and other graduate or undergraduate courses at Hitotsubashi University, including Japanese language courses.

*Some courses are not open for exchange students.

Students spend one year at IPP and one year at their home university, seeking two degrees from both universities. The curriculum is catered to double-degree students to fulfill degree requirements, which allows them to explore two academic disciplines in depth, gaining a comprehensive understanding of both subjects.

Study period: one or two semesters

Language requirement: English fluency (TOEFL iBT 80 or equivalent score is preferred.)

Admission period: Mid-April for Autumn semester
Mid-October for Spring semester

Tuition and fees: Pay tuition and fees to home universities.

Prof. Akiyama served as the Minister Counsellor at Japan's Permanent Mission to the International Organizations in Vienna (2016-2018) and is a member of the Public Security Examination Commission at the Ministry of Justice. His expertise is international security, with a particular focus on nuclear non-proliferation and nuclear disarmament.



Associate Prof. KWON, Yongseok

Ph.D. in Law, Hitotsubashi University. Visiting scholar at Seoul National University and Waseda University. His area of expertise is the history of Korea, Japanese diplomacy, and East Asian international relations. His research focuses on the cultural aspects of the Japan-Korea relationship, including pop culture and sports.

Ph.D. in Political Science, George Washington University. Prof. Ichihara is the steering committee chair of the East Asia Democracy Forum, and serves on steering committees of the World Movement for Democracy, Japan Factcheck Center, and International Coalition for Democratic Renewal.
